## LITTLE MISS RODEO NEW MEXICO PAGEANT 2026

We are excited that you are interested in the Little Miss Pageant to be held during the Miss Rodeo New Mexico Pageant Fashion Show. By including these beautiful young ladies in the Miss Rodeo New Mexico Pageant, we are showcasing future rodeo queens and building their interest in being a part of this family of rodeo royalty.

Little Misses Rodeo New Mexico are young ladies between the ages of 6 and 10 years of age as of November 1, 2025. Little Misses must follow the same rules as the other age groups. Title holders must sit out one year before competing again.

Little Miss contestants will be individually interviewed by the judges.

During the stage portion each contestant will present a speech of up to 1.5 minutes in length. They will also model a western outfit of their choosing. This may be a western dress, a "western trendy" (modern) western outfit, or jeans and shirt, but all will be with a cowboy hat and boots. They will be asked a very simple question while being interviewed on the stage by our master of ceremonies.

At the end of the pageant all will be declared winners and will be presented with a perpetual crown and banner reading "Little Miss Rodeo New Mexico." Buckles are available for purchase if desired.

The Little Misses are required to help with fund raising, attend the Gala, be present at the Queen's Trunk Show and attend the Pageant the following year. They do not have any other mandatory appearances during the year but are encouraged to represent our pageant and their title at any function they wish by wearing their crown and banner. They are asked to keep the National Director advised of any activities and provide appropriate photos to be posted on the official Facebook site!

The entry fee of \$125 must be submitted with the required documentation and postmarked by August 1, 2025. No late entries will be accepted to allow for program printing.
